Serviço Nacional de Informações: Uma Abordagem Histórica Aloysio Henrique Castelo de Carvalho, 2023-05-04 O livro investiga três momentos na relação do sistema de inteligência com o regime militar. A fase de afirmação das instituições do autoritarismo foi marcada pela criação do SNI e reorientação do papel desempenhado pelos órgãos de informações das Forças Armadas que passaram a exercer vigilância sobre os movimentos sociais. Com o recrudescimento ideológico do autoritarismo, que se estendeu de 1968 a 1973, o SNI e os órgãos de informações militares expandiram sua influência e se tornaram o núcleo de poder com maior capacidade para definir as políticas relacionadas à segurança do Estado. O processo de transição foi acompanhado pela redefinição do sistema de inteligência que enfatizou o papel hegemônico do SNI, em detrimento dos órgãos de informações das Forças Armadas. Seja na fase transição ou após os militares deixarem o exercício de governo, o SNI consolidou-se como órgão centralizador do Sisni e continuou a desempenhar as funções de natureza policial em consonância com o projeto que lhe deu origem. Quando idealizado pelos militares da Escola Superior de Guerra no ano de 1953, no contexto democrático do governo Vargas, o SNI foi projetado como órgão auxiliar do CSN. Vimos que houve uma superação dessa proposta no decorrer do regime militar. O SNI e os serviços de inteligência assumiram um protagonismo político e passaram a ocupar o centro da estrutura de poder com maior autoridade sobre as questões de segurança interna e institucionalização do regime. Com a colaboração dos órgãos de informações das Forças Armadas, o SNI alcançou expressiva dominância no âmbito do esquema decisório governamental, como ficou demonstrado na crise de 1968 quando desempenhou o papel principal em defesa das políticas repressivas adotadas com AI-5. Orientado pela concepção autoritária da informação como um instrumento de segurança nacional e amparado por uma considerável estrutura de comunicação com boletins, estudos, relatórios e informes, o sistema de inteligência encabeçado pelo SNI difundiu estimativas no interior do aparelho estatal e persuadiu o conjunto da oficialidade dirigente sobre os riscos institucionais que o regime e a revolução de 1964 corriam diante de um plano subversivo para a tomada do poder, de caráter revanchista e antimilitarista.

O Intercâmbio Internacional de Informações Tributárias no Brasil Frederico Silva Bastos, 2015-07-27 O fenômeno da globalização impôs às administrações tributárias o desenvolvimento de políticas fiscalizatórias à luz de contribuintes e operações compreendidas em âmbito internacional. A maior integração entre os países intensificou o desafio das autoridades

fiscalizadoras no combate ao planejamento tributário agressivo e aos crimes financeiros e tributários. Nesse contexto, o intercâmbio internacional de informações surge como ferramenta concebida e estruturada para servir aos interesses das administrações tributárias. No entanto, ao realizar suas competências fiscalizatórias, os governos permanecem sujeitos a respeitar os direitos garantidos aos cidadãos. Sob essas premissas, a obra propõe-se a delinear a moldura regulatória e prática do intercâmbio internacional de informações tributárias realizado pela Receita Federal do Brasil, apontando e discutindo objetivamente as tensões entre essa ferramenta de cooperação internacional e os direitos e garantias fundamentais assegurados pela Constituição Federal.

Assimetria De Informações Em Investimentos Para Startups: Um Estudo Segundo A Análise Econômica Do Direito Lucas Vinícios Cruz, O presente trabalho proporciona um debate científico sobre a possível existência de assimetria de informações em investimentos feitos por fundos de venture capital (VC) e private equity (PE) em startups. O objetivo desta pesquisa é analisar a existência de assimetria de informações nos investimentos feitos em startups, com foco em fundos de venture capital e fundos de private equity, de modo apurar os problemas jurídicos e econômicos que a assimetria de informações pode causar ao fundo investidor, bem como apresentar possíveis soluções para que o fundo possa acabar ou reduzir a assimetria informacional, fazendo com que o investimento seja mais eficiente. Assim, buscou-se responder ao seguinte problema: a eventual existência de assimetria de informações pode impactar, jurídica e economicamente, em investimentos para startups feitos através de fundos de venture capital e private equity? Caso positivo, de qual forma? Como hipótese de resposta sugerida ao problema, através de uma análise doutrinária, jurídica e econômica, demonstrou-se que a resposta é positiva, isto é, que a assimetria de informações pode impactar negativamente em investimentos feitos por fundos de venture capital e private equity em startups, acarretando alocações ineficientes de recursos escassos, contribuindo para que o investimento seja menos eficiente, com maior risco, maior custo de transação, menor potencial de maximização dos interesses, riquezas e bem estar. Para fundamentar e justificar a resposta ao problema levantado, ao longo do texto desta pesquisa, serão invocadas ferramentas metodológicas relativas à Análise Econômica do Direito (AED) ou Law and Economics, tais como eficiência, alocação de recursos escassos, incentivos, custos de transação, custos de agência, problema de agência, risco moral, seleção adversa e maximização do bem-estar. Ao final, o objetivo inicialmente proposto para esta pesquisa foi alcançado, com a validação da hipótese sugerida para o problema proposto, pois, conforme apurado ao longo desta pesquisa, a eventual existência de assimetria de informações pode trazer problemas para investimentos feitos em startups através de fundos de venture capital e private equity, aumentando os custos de transação e acarretando em alocações ineficientes de recursos escassos.

Inteligência e Segurança Nacional no Brasil Pós-1964: A Comunidade de Informações Aloysio Castelo de Carvalho, 2021-05-26 O livro *Inteligência e Segurança Nacional no Brasil pós-1964* investiga os órgãos pertencentes à

Comunidade de Informações que foi reorganizada e expandida no regime militar. Entre os órgãos da Comunidade de Informações que atuaram em defesa do regime, o Serviço Nacional de Informações (SNI) e o Destacamento de Operações de Informações-Centro de Operações de Defesa Interna (Doi-Codi) distinguiram-se pelas atividades que realizaram no campo da vigilância e repressão. O SNI foi o modelo fundador dos serviços de inteligência criados após 1964. Ele se tornou o eixo central em torno do qual foi estruturada a Comunidade de Informações, comandada pelos dirigentes militares. Concebida em 1953 durante o governo Vargas, no bojo do Anteprojeto de Reestruturação do Conselho de Segurança Nacional (CSN), a proposta de criação do SNI sinalizou para um novo tipo de Estado que estava sendo idealizado pela inteligência da Escola Superior de Guerra (ESG), caracterizado por uma estrutura mais centralizada, submetido ao domínio das Forças Armadas e com maior capacidade de exercer a vigilância sobre a sociedade. O princípio da informação centralizada que moldou a estrutura do SNI foi incorporado pelo Doi-Codi, uma unidade militar de inteligência criada para combater diretamente as organizações revolucionárias que promoviam ações armadas contra o regime militar. Embora exercessem funções diferenciadas no aparelho repressivo, o SNI e o Doi-Codi eram órgãos de informações. Eles executavam operações de informações que eram realizadas no quadro das atividades de inteligência, com a finalidade de buscar conhecimento sobre o inimigo. Como uma unidade do Exército, o Doi-Codi possuía uma estrutura de comando militar que centralizava as operações de inteligência e coordenava as fases da produção de informações com a missão de destruir os centros propagadores da guerra revolucionária. O SNI e o Doi-Codi formaram os dois pilares da Comunidade de Informações, representada pelo Sistema Nacional de Informações (SISNI) e Sistema de Segurança Interna (SISSEGIN), que foram estruturados no início da década de 1970, durante o governo Médici. As operações integradas marcaram a trajetória desses órgãos de informações que denomino de polícia política. Esse conceito sugere que as operações de inteligência tinham um caráter político-ideológico, uma vez que visavam a eliminar as ameaças internas e garantir o regime militar, de acordo com a agenda formulada para a segurança nacional.

O acesso aos metadados pelos Serviços de Informações da República Portuguesa Mariana Gomes

Machado, 2020-03-01 A Constituição interdita o acesso a metadados (dados de dados) por parte dos serviços de informações, para efeitos de prevenção do terrorismo e espionagem? Na presente obra, perscrutam-se os antecedentes e a evolução, constitucional e legal, do arquetipo dos serviços, após a Constituição de 1976, percorre-se o quadro legal de países congêneres e a jurisprudência do TEDH e do TJUE. Problematisa-se sobre as antinomias do arquetipo legal dos serviços, aventando-se o início de um debate público sobre a sua natureza jurídica, atribuições e competências. Sustenta-se que o art.º 27.º, n.º 1, da Constituição encerra um direito fundamental a segurança, autónomo face ao direito a liberdade e que os metadados, por não consentirem acesso ao conteúdo de comunicações e pesquisas na internet, estão excluídos do âmbito e programa do art.º 34.º. Sem prejuízo, a ingerência desencadeada posterga o direito a reserva da intimidade da vida privada, cuja aferição da constitucionalidade demanda a realização de um juízo de ponderação.

Disclosure Corporativo e as Informações ESG na Perspectiva do Mercado de Capitais Fernando Dal-Ri

Murcia, 2024-05-17 O presente livro aborda o tema do disclosure das companhias por meio de um enfoque abrangente, tangenciando as áreas de Contabilidade, Finanças e Economia. A divulgação de informações no âmbito do mercado de capitais é fundamental para reduzir a assimetria informacional e o problema da seleção adversa. O disclosure corporativo reduz a assimetria aproximando os níveis de informação entre os participantes do mercado, possibilitando que os agentes econômicos tomem melhores decisões relativas à compra e venda de valores mobiliários. Do mesmo modo, também possui uma importante função de governança na medida em que mitiga os efeitos do problema do risco moral, já que faz com que as ações dos administradores se tornem públicas, funcionando como um importante mecanismo de controle e monitoramento. A obra também trata, de forma específica, da divulgação financeira relacionada à sustentabilidade, no contexto da criação do novo regulador internacional - International Sustainability Standards Board (ISSB) - e a emissão das novas normas IFRS S1 e IFRS S2. Neste cenário, o livro apresenta os resultados de uma pesquisa empírica com as práticas de divulgação sobre sustentabilidade das maiores empresas da Bolsa de Valores Brasileira B3, incluindo exemplos práticos e ilustrativos considerando os requerimentos previstos na IFRS S1 - Requisitos Gerais para Divulgação de Informações Financeiras Relacionadas à Sustentabilidade.

Apresenta-se também os benefícios que os registros trazem para a profissão, além de utilizar como base alguns estudos para discutir sobre alguns outros aspectos, tais como: o conteúdo dos registros, a responsabilidade pelos documentos — como sigilo das informações — segurança, manutenção, cuidados e características de registros eletrônicos e digitais, barreiras para a implementação de registros, dentre outros. Permeando essas colocações, as diretrizes da APA sobre elaboração de registro foram amplamente apresentadas durante os capítulos no intuito de trazer mais direcionamentos para o estabelecimento de boas práticas de registro. Por fim, foi disposto ao final do livro um experimento cujo objetivo foi comparar o custo da resposta entre o registro cursivo e o registro digitado. Para isso, foram contabilizados os tempos das tarefas experimentais realizadas por duas Psicólogas e um Psicólogo de uma clínica de Psicologia, dividindo as sessões entre as duas modalidades em questão. Os resultados mostraram diferenças nos tempos obtidos entre os participantes e entre as condições, e constatou-se que o custo

da resposta do registro cursivo é mais elevado do que o registro digitado. Com isso, finaliza-se com uma discussão acerca do tema e de algumas implicações para o cotidiano da pessoa profissional de Psicologia.
